Notice Concerning Acquisition of SBT Certification, an International Climate Change Initiative

DTS CORPORATION (“DTS”) hereby announces that it has established greenhouse gas emissions reduction targets toward FY2030 and has obtained the Science Based Targets (SBT)*1 certification, an international climate change initiative.



In its long-term vision, Vision2030, DTS has set greenhouse gas emissions reduction targets for the DTS Group, and has obtained the SBT certification as the targets are in line with the levels required to achieve the 1.5°C goal aimed for by the Paris Agreement. In order to meet the targets, DTS is promoting the use of renewable energy at its offices (Scope 2) and the reduction of greenhouse gas emissions in collaboration with its suppliers and business partners (Scope 3). In addition, DTS will be committed to responding to CDP questionnaires and disclosing information in line with the recommendations of the Task Force on Climate-related Financial Disclosures (TCFD), and contribute to the development of a decarbonized and sustainable society.

*1 SBT: Greenhouse gas emissions reduction targets set by companies for target years of five to ten years from now that are in line with the levels required by the Paris Agreement. Administered by the Science Based Target initiative, a joint initiative of four organizations, namely, CDP, the United Nations Global Compact (UNGC), World Resources Institute (WRI), and the World Wide Fund for Nature (WWF).

*2 Scope 1: Direct emissions of greenhouse gas by a business operator itself (fuel combustion and industrial processes)

*3 Scope 2: Indirect emissions from the use of electricity, heat, and steam supplied by other companies

*4 Scope 3: Indirect emissions not included in Scope 1 and Scope 2 (emissions from other companies related to the activities of the business operator)
