Notice on Revisions of Forecasts

(hereinafter the "Company") hereby announces a revision of its consolidated financial forecasts both for the first half and full year ending December 31, 2021, which the Company announced at the analyst meeting for business results on February 15, 2021, based on recent business performance.

3. Reasons for the Revision

The Company expects its consolidated sales and income for the second half of the FY2021 to substantially exceed the previous forecast due to, accompanied with an increased demand for semiconductors, its advanced materials such as photoresist for semiconductors and high density integration materials used mainly for backend semiconductor manufacturing processes, putting up a good performance mainly in Asia.

The Company expects its consolidated financial results for the FY2021 to exceed the previous forecast allowing for the performance of the first half and market outlook going forward.

The above forecasts in this release are estimated based on the information that the Company have been able to obtain as of the date of this release. Actual results to be disclosed in the future might differ from the forecasted figures above for various reasons including risk factors
