Notice Concerning Debt Financing

Japan Excellent, Inc. (hereinafter “JEI”) announces the decision made today concerning new debt financing as follows.

1. Details of Debt Financing

JEI intends to apply the proceeds of the loan to repayment of the long-term borrowings of ¥3.0 billion (described in “Notice Concerning Debt Financing” announced on December 22, 2016) scheduled to fall due and payable on January 31, 2022.

- (i) Detailed Use of Proceeds : To be used for the repayment of long-term borrowings of ¥3.0 billion scheduled to fall due and payable on January 31, 2022
- (ii) Scheduled Expenditure Date : January 31, 2022
