Announcement Regarding the Status and Completion of Repurchase of Own Shares
(Repurchase of the Company's shares in accordance with the Articles of Incorporation under
Article 165, paragraph 2 of the Companies Act)

ITOCHU Corporation ("ITOCHU") decided at the meeting of the Board of Directors held on January 19, 2022 to repurchase own shares in accordance with Article 156 of the Companies Act of Japan, as applied pursuant to Paragraph 3, Article 165 of the Companies Act of Japan.

ITOCHU hereby announces the status of the repurchase as follows.

ITOCHU also announces that the repurchase pursuant to the above resolution has been completed.

1. Progress of the repurchase until March 24, 2022

- (1) Type of shares repurchased: Common stock of ITOCHU
- (2) Total number of shares repurchased: 6,099,000 shares
- (3) Total amount: 23,958,238,000 yen
- (4) Period: From March 1, 2022 to March 24, 2022
