At the centers, our staff with specialized medical clerical skills respond online in real time, allowing clinics to operate with a minimum of clerical staff. In addition, by performing medical office work from the remote medical administration centers, patients' waiting time is reduced and avoiding the 3Cs can be expected.

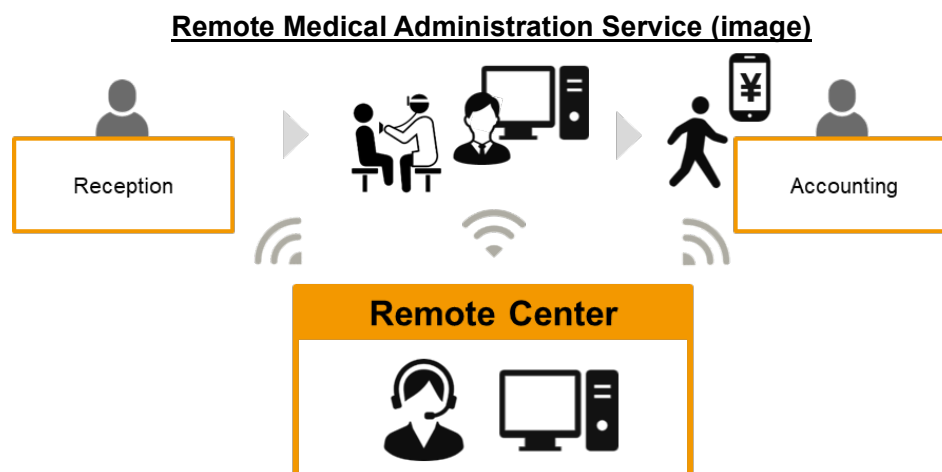

DXing Clinic Medical Administration Work with *iisy* **100 clients for Remote Medical Administration Services, acquired** ~ Over 100 application contracts in the first 10 months since service launched! ~

Solasto Corporation (TSE: 6197) is pleased to announce that the number of customers who have contracted with the Remote Medical Administration Service, the first service of its medical DX package "*iisy*," exceeded 100 at the end of March 2022. Since its launch on June 2021, the service has reached this milestone in just 10 months.

■ The features of the clinic that decided to introduce the service

1. Newly opened clinics

There are many concerns and anxieties related to "personnel" when opening a clinic. We have received many comments from doctors who have opened new clinics that "labor management was reduced and the opening of the clinic went smoothly."

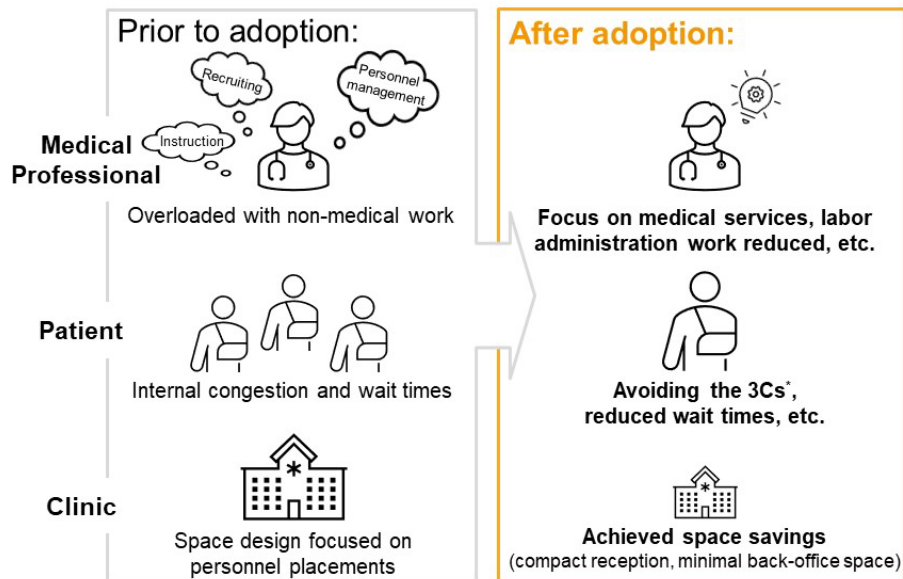
2. Major medical corporation operating more than 10 clinics

We have received applications from "Nagoya Garden Clinic" (in AEON Mall Nagoya Noritake Garden :large shopping center), which has a total of 20 departments, and from a medical corporation with more than 10 clinics.

3. Applications from all over the country

We are receiving an increasing number of applications from the Tokyo area as well as from mountainous areas, remote islands, and other remote areas where it is difficult to hire human resources. We have also heard from some doctors who say, " If staff members suddenly quit, it is difficult to hire new staff right away."
