Notice Regarding Stock Repurchase

(Repurchases of Shares of the Company's Own Stock in Accordance with the Provisions of Articles of Incorporation Pursuant to Article 459, Paragraph 1 of the Companies Act)

Tokyo, April 28, 2022– Fujitsu Limited (hereinafter the Company) announces that it has made a resolution at its Board of Directors Meeting held today to repurchase shares of its own stock, pursuant to the provisions of Article 459, paragraph 1 of the Companies Act, as well as the Company's articles of incorporation, as follows.

1. Reason for the Repurchase of Our Own Shares

Based on improved financial conditions for fiscal 2021 and fiscal 2022, including increased profits and cash flow, the Company has thoroughly reviewed the future business environment and other factors and will repurchase its own stock to enhance shareholder returns and promote capital efficiency.
