The Company has executed the absorption-type merger wherein the Company was the surviving company, and Maxell, Ltd. used to be a consolidated subsidiary of the Company was the absorbed company. And the Company has dissolved the holding company structure and changed the corporate name of the Company from Maxell Holdings, Ltd. to Maxell, Ltd., as of October 1, 2021.

Also, Maxell, Ltd. absorbed in the absorption-type merger has been classified as a specified subsidiary of the Company. (2) Changes in accounting policies, accounting estimates and restatement

1) Changes as a result of revision of accounting standards: Yes Application of Accounting Standard for Revenue Recognition

The Company has applied "Accounting Standard for Revenue Recognition" (ASBJ Statement No. 29 of March 31, 2020), etc. from the beginning of this consolidated fiscal year and revenue is recognized at the time when the goods or services arrived (including when they were deemed to arrive) to customers in domestic sales instead of at the time of shipment. In addition, for those transactions that the Company purchase raw materials from the customer and sell to such customer after processing supplied materials, the revenue is recognized in the net amount excluding the purchase price of raw materials while it used to include the purchase price of raw materials before. Off-set will not be applied for paid transaction of these materials in such cases.

With regard to the application of the Accounting Standard for Revenue Recognition, in accordance with the transitional treatment stipulated in the provisions of paragraph 84 of the Accounting Standard for Revenue Recognition, the cumulative effect of retrospective application of a new accounting policy prior to the beginning of this consolidated fiscal year has been adjusted to retained earnings at the beginning of the fiscal year under review, and a new accounting policy has been applied from the beginning of this consolidated fiscal year. However, the new accounting policy has not been applied retrospectively to contracts for which the method set forth in paragraph 86 of the Accounting Standard for Revenue Recognition has been applied and substantially all revenue amounts have been recognized in accordance with previous treatment prior to the beginning of this consolidated fiscal year.

As a result, in this consolidated fiscal year ended March 31, 2022, notes and accounts receivable-trade decreased by 72 million yen, inventories decreased by 189 million yen, other accounts receivable increased by 386 million yen and accounts payable-other increased by 146 million yen in the consolidated balance sheets. Also, net sales decreased by 3,560 million yen, cost of sales decreased by 3,313 million yen, selling, general and administrative expenses decreased by 161 million yen, non-operating expenses decreased by 65 million yen, operating profit decreased by 86 million yen, and ordinary profit and profit before income taxes decreased by 21 million yen each in the consolidated statements of income. There is no influence to the balance of retained earnings in the consolidated statements of changes in net assets at the beginning of this consolidated fiscal year.

1. Business Performance

(1) Analysis of Business Performance

1) Overview

(Unless otherwise stated, all comparisons are with operating results of the same period of the previous fiscal year, from April 1, 2020 to March 31, 2021.)

The global economy during this consolidated fiscal year continued to be impacted by Novel Coronavirus (COVID-19) for two years from the previous consolidated fiscal year, as the number of infections increased rapidly in the fourth quarter due to emergence of new variant. Against this situation, the gradual recovery in the markets such as automotive and semiconductors led to a recovery trend in the Group's businesses. However, new geopolitical risks such as a sudden change in the Russia-Ukraine situation led to concerns that the impact of soaring raw material and energy prices, shortage of semiconductors, and stagnant logistics will continue for an even longer period from the fiscal year ending March 31, 2023 onward.

Under these circumstances, net sales for the fiscal year under review decreased by 0.6% (840 million yen) to 138,215 million yen mainly due to the downsizing of projector business as a pillar of business portfolio reforms, although the sales of products for automotive and semiconductor markets increased. In terms of profitability, in addition to the improvement of profitability of the products performed well, having the effects of business reforms and reduction of unprofitable businesses promoted in the previous fiscal year and cost reduction measures, as well as efforts to reflect higher raw material costs in sales prices, operating profit increased by 145.2% (5,526 million yen) to 9,332 million yen, which was the highest figure since the re-listing in March 2014. Ordinary profit increased by 157.1% (6,042 million yen) to 9,888 million yen. On the other hand, regarding profit attributable to owners of parent, the Company recorded loss of 3,659 million yen mainly due to recognition of loss on valuation of investment securities amounted 10,312 million yen.

The average foreign exchange rate over the year under review was US\$1=112 yen.

The Company has applied "Accounting Standard for Revenue Recognition" (ASBJ Statement No. 29 of March 31, 2020), etc. from the beginning of this consolidated fiscal year.

Operating results by segment are as follows. The Company has changed its business segment from this consolidated fiscal year, and the analysis and comparisons are made based on the new segment.

Energy

Although sales of lithium ion battery for consumer decreased due to production decrease at customers caused by the supply shortage of semiconductors, supported by increased sales of heat resistant coin type lithium battery following recovery of demand in automotive market, coin type lithium rechargeable batteries mainly for hearing aids and cylindrical type lithium batteries mainly for smart meters, sales for Energy segment increased by 2.2% (820 million yen) to 38,631 million yen. In terms of profitability, operating profit increased by 22.4% (741 million yen) to 4,050 million yen, reflecting the effects of cost reduction measures and sales increase of heat resistant coin type lithium battery, etc. despite negative factors such as soaring raw material costs for batteries in general and sales decrease of lithium ion battery for consumer use.

Functional Materials

Although sales of coated separator decreased due to the application of the Accounting Standard for Revenue Recognition, etc., sales for Functional Materials segment increased by 1.3% (364 million yen) to 28,018 million yen due to sales increase of adhesive tapes and industrial rubber products. Operating profit increased by 69.2% (761 million yen) to 1,861 million yen due to increase of profit of industrial rubber products by sales increase, as well as profit increase of coated separator, despite the effect of soaring raw material cost has been increased for adhesive tapes.

Optics & Systems

Although sales of projector decreased due to termination of sales in Americas, Europe and Asia (excluding China and South Korea), sales for Optics & Systems segment increased by 2.4% (928 million yen) to 39,540 million yen due to sales increase of semiconductor related embedded systems following recovery of semiconductor market, optical components for automotive market such as in-car camera lens unit and LED headlamp lens, as well as sales increase led by start of mass-production of head up displays. Operating profit increased by 6,272 million yen to 3,338 million yen due to effect of business reform for projectors and improvement in profitability of optical components for automotive market and head up displays and profit increase of semiconductor related embedded systems, etc.

Life Solution

In addition to decrease in sales of health related products due to a slowdown in sales of anti-bacterial deodorizer, for which demand had increased during the previous fiscal year due to the spread of COVID-19 and the impact of business transfer of part of health products, sales of beauty care products and other consumer products such as optical disks decreased. Due to these reasons, sales for Life Solution segment decreased by 8.4% (2,952 million yen) to 32,026 million yen. Operating profit decreased by 96.4% (2,248 million yen) to 83 million yen, due to decrease of profit for health related and beauty care products.

2) Outlook

As for the global economic environment, although the impact of COVID-19 will not be completely eliminated even in the fiscal year ending March 2023, the Company expects that restrictions on economic and social activities will gradually be eased. On the other hand, uncertainty is increasing due to a sudden change in the Russia-Ukraine situation as a new geopolitical risk in the fourth quarter of this consolidated fiscal year, and there are concerns about further rises in raw material and energy prices, the prolonged shortage of semiconductors, the impact of these on production, such as automotive, and stagnation and rising costs in logistics.

In this situation, the Group continues to manage profitability by thoroughly implementing financial discipline and promote business replacements by business portfolio reform in the fiscal year ending March 2023. In addition, the Group also continues to promote thorough cost reduction measures and reflect current cost increases on sales pricing. Through these measures, the Group will aim to achieve targets of the Mid-Term Plan MEX23, such as operating profit ratio of 10% and ROIC of 7% or higher in the fiscal year ending March 2024.

Consolidated business forecast for the fiscal year ending March 2023 is, Net sales: 130,000 million yen, Operating profit: 9,500 million yen and Profit attributable owners of parent: 6,000 million yen. Net sales are expected to fall short of the results for the fiscal year ended March 2022 in order to further deepen business portfolio reforms by concentrating management resources on businesses that should grow. However, in line with basic policy of MEX23 "Commit to Value (corporate value and profit growth)", the Company plans to focus on strengthening profitability.

These numbers are based on calculation using the average exchange rate over the fiscal year, 120 yen to the U.S. dollar. For projections of business performance by segment, please refer to the supplementary information on page 7.

(2) Analysis of Financial Position and Cash Flow

1) Assets, liabilities and net assets

Assets

As of March 31, 2022, total assets amounted 177,535 million yen, increased by 0.4% from the previous consolidated fiscal year. Among this, current assets amounted 99,469 million yen, increased by 16.5%, mainly by increase of cash and deposits, and inventories. And the ratio of current assets among total assets has changed to 56.0% from 48.3% of the previous consolidated fiscal year. On the other hand, non-current assets amounted 78,066 million yen, decreased by 14.6%, and the ratio of non-current assets among total assets has changed to 44.0% from 51.7% of the previous consolidated fiscal year.

Liabilities

As of March 31, 2022, total liabilities amounted 92,919 million yen, decreased by 0.3% from the previous consolidated fiscal year. Among this, current liabilities amounted 57,719 million yen, increased by 17.9%, mainly by increase of current portion of long-term borrowings and other current liabilities, although accrued expenses and short-term borrowings decreased. And the current ratio became 1.7 times, and the cash on hand which is the balance between current assets and current liabilities, became 41,750 million yen. On the other hand, non-current liabilities amounted 35,200 million yen, decreased by 20.4%, mainly by decrease of long-term borrowings.

Net Assets

As of March 31, 2022, total net assets amounted 84,616 million yen, increased by 1.2% from the previous consolidated fiscal year. The increase is mainly by increase of accumulated other comprehensive income, although there was record of net loss of 3,659 million yen in profit attributable to owners of parent. And the equity ratio was 45.9% which is same as the previous consolidated fiscal year.

2) Cash flow

In the current consolidated fiscal year, cash and cash equivalents (hereinafter referred to as funds) increased by 10,542 million yen to 43,337 million yen. This total comes from income of 18,442 million yen as cash flows from operating activities, expenditure of 3,908 million yen as cash flows from investing activities and expenditure of 6,211 million yen as cash flows from financing activities. Respective cash flows are as follows.

Cash Flows from Operating Activities

Net cash provided is 18,442 million yen in cash flow from operating activities in the current consolidated fiscal year. This mainly derives from increase in funds includes 10,312 million yen of loss on valuation of investment securities, 4,542 million yen of depreciation, 1,004 million yen of decrease in trade receivables, 1,251 million yen of increase in trade payables and 14,086 million yen of increase in advances received, and deduction in funds includes 1,549 million yen of loss before income taxes, 1,338 million yen of increase in inventories, 8,851 million yen of decrease in accrued expenses and 4,324 million yen of income taxes paid.

Cash Flows from Investing Activities

Net cash used is 3,908 million yen in cash flow from investing activities in the current consolidated fiscal year. This mainly derives from deduction in funds includes 4,030 million yen of purchase of property, plant and equipment, 2,215 million yen of payments into time deposits and 1,112 million yen of purchase of intangible assets, and increase in funds includes 2,403 million yen of proceeds from sale of investment securities.

Cash Flows from Financing Activities

Net cash used is 6,211 million yen in cash flow from financing activities in the current consolidated fiscal year. This mainly derives from deduction in funds includes 3,500 million yen of net decrease in short-term borrowings, 1,598 million yen of repayments of long-term borrowings and 990 million yen of dividends paid.
