### **Notice Regarding Repurchase of the Company's Own Shares**

This is to notify that the company, at the Board of Directors' meeting held on May 13, 2022, has decided to repurchase its shares in the market under Article 156 of the Japanese Corporation Act, as applied pursuant to Article 165, Paragraph 3 of the same Act.

#### 1. Purpose of repurchase

To facilitate flexible implementation of capital policy in response to changes in the business environment.

#### 2. Details of repurchase

- (1) Class of shares: Common shares of the company
- (2) Total number of shares: Up to 1,000,000 shares  
(0.71% of total shares outstanding, excluding treasury shares)
- (3) Total amount: Up to 5,000,000,000 yen
- (4) Period of repurchase: From May 16, 2022 to July 29, 2022
