Its purpose is to take advantage of industry-government-academia collaboration in order to standardize each process of cell therapy services for domestic animals (dogs and cats) and achieve the practical application of a system that makes it possible for veterinarians at all kinds of medical facilities to provide safe and effective cell therapy services.

"Animal Health Encyclopedia" is a website operated by Anicom Insurance that allows users to search for data on diseases and medical fees. By eliminating the information gap between pet owners and veterinarians, it aims to help pet owners choose better treatments, achieve early and complete cures for diseases, and reduce insurance costs. It also aims to promote the standardization of veterinary care, which will lead to appropriate insurance claims.

The "Veterinary Clinic Search Site" is a website operated by Anicom Insurance that allows users to search for veterinary clinics accepting Anicom's insurance.
