Noda City and ITOCHU Advance Logistics Investment Corporation Signed an Agreement on the use of Logistics Facilities in the event of a disaster

ITOCHU Advanced Logistics Investment Corporation ("IAL"), which is managed by ITOCHU REIT Management Co., Ltd. ("IRM"), has concluded an "Agreement on Acceptance of Evacuees and Relief Supplies in the Event of Disaster" with regard to a logistics facility owned by IAL, i Missions Park Noda ("IMP Noda"), with Noda City, Chiba Prefecture, on May 25, 2022. Under this agreement, in the event where Noda City is unable to accept relief supplies or disaster victims, IAL will provide a part of premises and buildings of IMP Noda for the storage and management of relief supplies and as a temporary evacuation site for disaster victims, thereby contributing to a prompt response to disaster relief efforts for local residents and citizens.

IMP Noda is an advanced logistics facility that enables efficient storage and unloading of cargo, and is equipped with rampways that allow easy access for vehicles in times of emergency, taking BCP (Business Continuity Plan) into consideration. By taking advantage of these facility characteristics, we aim to support the safety and security of local residents and citizens by mutually cooperating with Noda City in the event of a disaster.
