Notice of the Decision on the Matters Concerning Purchase of Treasury Stock (Purchase of treasury stock based on the provisions of the Company's Articles of Incorporation in accordance with Article 165, Paragraph 2 of the Companies Act)

Anritsu Corporation is pleased to announce that it resolved to purchase treasury stock as follows, at the Board of Directors meeting held on May 31, 2022, in accordance with the provisions of Article 156 of the Companies Act as applied by replacing the term and phrase pursuant to the provisions of Article 165, Paragraph 3 of the said Act.

- 1. Reason for purchase of treasury stock
 For enhancing capital efficiency as well as further substantial returns to shareholders
