# Notice Concerning the Group Reorganization (Establishment of Subsidiary, Intergroup business transfers, and Change of Name of Consolidated Subsidiary)

ENECHANGE (hereinafter referred to as "the Company") announces that the Company resolved at the Board of Directors meeting held on August 12, 2022, to establish a new subsidiary, transfer the SMAP business of SMAP Energy Limited (hereinafter referred to as "SMAP Energy"), a consolidated subsidiary of the Company, to the Company, and change the company name of SMAP Energy, for the purpose of efficient utilization of management resources within the Group.

# 1. Establishment of Subsidiaries

①Purpose of Establishment of Subsidiary

The Company has been in the EV Charging business since November 2021, offering EV charging services for a monthly fee under the brand name "ENECHANGE EV Charge". Domestic new vehicle sales of EVs and PHVs reached a record high of 3.3% (Note) in the second quarter of 2022. Along with the future growth of the EV market, demand for EV charging facilities is expected to increase, and we have a policy of expanding our business through aggressive upfront investment.

Based on this policy, we have established a new subsidiary, ENECHANGE EV Lab Ltd., which specializes in the development and procurement of hardware and software related to EV charging facilities, in order to realize more efficient business operations while making aggressive upfront investments in the EV Charging business.

## 2. Intergroup business transfers

#### (1) Reason for business transfer

SMAP Energy, a consolidated subsidiary based in the U.K., has been developing and selling the electricity smart meter data analysis SaaS "SMAP," centered on the "SMAP DR" demand response (DR) service, which realizes electricity savings by utilizing smart meter data.

SMAP Energy will transfer its "SMAP business," which focuses on the development and sales of DR products such as "SMAP DR," to the Company in order to consolidate functions related to the Data business, realize more efficient business operations, and respond to the recent increase in demand for energy-saving services in Japan.

SMAP Energy will focus on providing strategic support to the Company through the provision of specialized consulting and development services. This function will include:

- 1. Identifying opportunities in the global energy sector for investment in overseas decarbonization tech ventures (through the "Decarbonized Tech Fund" managed by the Company)
- 2. Negotiating and building business alliances with these ventures for expansion in Japan
- 3. Maintaining relationships with an international consortium of experts to advise and direct the Company on strategic initiatives
- 4. Providing broad market research and real-time monitoring of international developments in the global energy sector
- 5. Providing engineering resources and talent to prototype and develop new products for the Company, in addition to providing overflow support

SMAP Energy will also change its company name as described below.
