DeNA Co., Ltd. previously temporarily suspended the repurchase of own shares as of September 8, 2022 as described in 1. below per the disclosure of September 5, 2022 titled “Notice Regarding Temporary Suspension of Repurchase of Own Shares” and would now like to announce that the repurchase of own shares is expected to resume on September 20, 2022.
