Notice of Revisions to Dividend Forecasts

JGC Holdings Corporation (the “Company”) has revised the dividend forecasts for the fiscal year ending March 2023 (April 1, 2022 to March 31, 2023), released on August 10, 2022.

2. Reasons for revising dividend forecasts

The Company aims for a consolidated dividend payout ratio of 30% as its policy on shareholders return, and previously announced annual dividends forecast of 29.00 yen for the fiscal year ending in March 2023. We revised forecast of annual profit attributable to owners of parent to increase to 30 billion yen, described in “Summary-Consolidated Second Quarter Financial Statements” released today. As a result, we have revised our annual dividend forecasts to 36.00 yen based on this policy.
