Announcement Regarding the Status of Repurchase of Own Shares

(Repurchase of the Company's shares in accordance with the Articles of Incorporation under Article 165, paragraph 2 of the Companies Act)

ITOCHU Corporation ("ITOCHU") decided at the meeting of the Board of Directors held on October 4, 2022 to repurchase own shares in accordance with Article 156 of the Companies Act of Japan, as applied pursuant to Paragraph 3, Article 165 of the Companies Act of Japan. ITOCHU hereby announces the status of the repurchase as follows.

1. Progress of the repurchase until November 30, 2022
 - (1) Type of shares repurchased: Common stock of ITOCHU
 - (2) Total number of shares repurchased: 2,133,900 shares
 - (3) Total amount: 8,948,013,200 yen
 - (4) Period: From November 1, 2022 to November 30, 2022

2. Accumulated total of the repurchase until November 30, 2022 pursuant to the above resolution
 - (1) Total number of shares repurchased: 4,909,600 shares
 - (2) Total amount of shares repurchased: 19,599,261,400 yen
