Progress of Acquisition of Treasury Stock

Tokyo, February 1, 2023 ----- Wacom Co., Ltd. (the "Company") announces the progress of acquisition of its treasury stock pursuant to Article 156 of Japanese Companies Act, of which application is defined by both paragraph 1, Article 459 of the Companies Act and provisions of the Company's Articles of Incorporation, as follows.

1. Details of acquisition completed

- (1) Type of shares acquired: Common stock of the Company
- (2) Total number of shares acquired: 114,600 shares
- (3) Total acquisition cost: 70,200,300 Japanese yen
- (4) Acquisition period: From January 1, 2023, to January 31, 2023 (on a trade basis)
- (5) Acquisition method: Open market acquisition of shares on the Tokyo Stock Exchange

1. Details of the resolution at the meeting of the Board of Directors held on May 12, 2022

- (1) Type of shares to be acquired: Common stock of the Company
- (2) Total number of shares to be acquired: Up to 4,000,000 shares
Equivalent of 2.52% of outstanding shares (excluding treasury stock)
- (3) Total acquisition cost: Up to 2.0 billion Japanese yen
- (4) Acquisition period: From May 13, 2022 to March 31, 2023
- (5) Acquisition method: Open market acquisition of shares on the Tokyo Stock Exchange

2. Total shares acquired as of January 31, 2023 pursuant to the above resolution at the meeting of the Board of Directors

- (1) Total number of shares acquired: 1,642,200 shares
- (2) Total acquisition cost : 1,235,780,300 Japanese yen
