**Notice Concerning the Status of the Acquisition of Treasury Stock**  
**(Acquisition of Treasury Stock Based on the Articles of Incorporation**

JAPAN POST INSURANCE Co., Ltd. (hereinafter the “Company”) announces the status of the acquisition of its treasury stock notified on August 10, 2022, as described below. 1. Class of shares to be acquired: Common stock of the Company
