II. Change in organizational structure

JPX will change its organizational structure, effective April 1, 2023, in order to further strengthen the business execution system of JPXI, among other reasons.

1. JPX Market Innovation & Research, Inc.

The IT development functions of the IT Development Department and IT Business Department will be merged and reorganized into a new “IT Business Department,” which will be responsible for all the IT development functions of JPXI. The IT operational function of the current IT Business Department will be merged into the IT Services Department. Other necessary changes will also be made, such as integrating the functions of the IT Administration Office into JPX's IT Planning Department.
