### **Notice regarding change of the executive director of the investment corporation and president and CEO of the asset management company**

LaSalle LOGIPORT REIT (hereinafter referred to as “**LLR**”) announces a change of the executive director, as outlined below. In addition, LLR’s asset management company, LaSalle REIT Advisors K.K. (hereinafter referred to as “**LRA**”), also announces a change of president and CEO, and has decided to appoint a new president and CEO at the board of directors meeting held today, as outlined below.

#### 1. Change of executive director at LLR

LLR has received and accepted a resignation request from the current executive director Toshimitsu Fujiwara. Taira Jigami, substitute executive director, will assume the executive director position effective from May 1, 2023.

Note: Taira Jigami was appointed as a substitute executive director as of December 1, 2021 based on the general unitholders meeting held on November 19, 2021.

#### 2. Change of president and CEO at LRA

LRA has received and accepted a resignation request from the current president and CEO Toshimitsu Fujiwara. Taira Jigami, director and head of fund management, has been appointed as the new president and CEO effective from May 1, 2023.
