SANKEI REAL ESTATE Inc. ("SANKEI REAL ESTATE") announces that one of the portfolio assets as described below has acquired today the highest "Rank S" under CASBEE (Comprehensive Assessment System for Built Environment Efficiency) Certification for Real Estate.

1. Overview of "CASBEE for Real Estate" Certification

CASBEE (Comprehensive Assessment System for Built Environment Efficiency) is a system for comprehensively assessing and ranking the environmental performance of buildings with regard to aspects such as the enhancement of environmental quality and performance including indoor comfort and consideration for the landscape, in addition to the aspect of environmental consideration such as energy-saving and the use of materials and equipment with a lower environmental burden.

CASBEE for Real Estate was developed for the purpose of using the environmental assessment of buildings prepared in accordance with CASBEE to evaluate real estate. It is scored by five evaluation items: energy & greenhouse gases, water, resource use & safety, biodiversity & land and indoor environment. By doing this, it is evaluated by four ranks: S, A, B+ and B.
