**Changes in Organization of Asset Management Company**

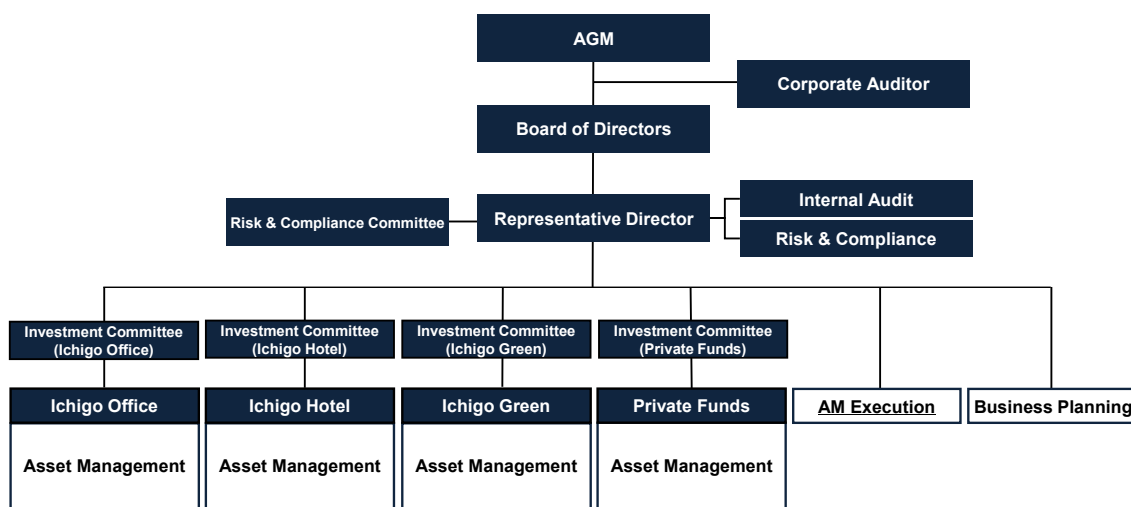

1. Corporate Reorganization (effective May 1, 2023)

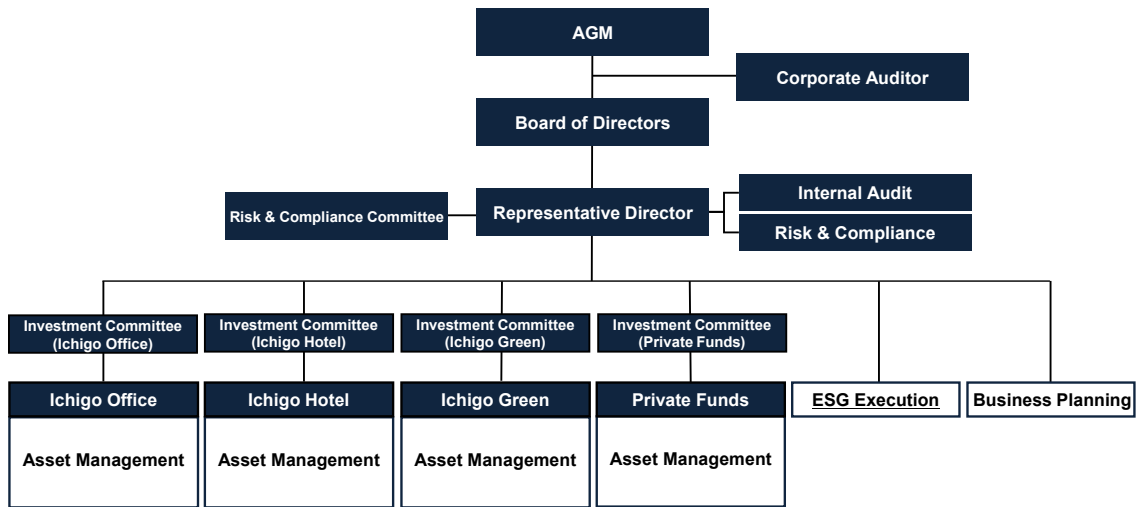
