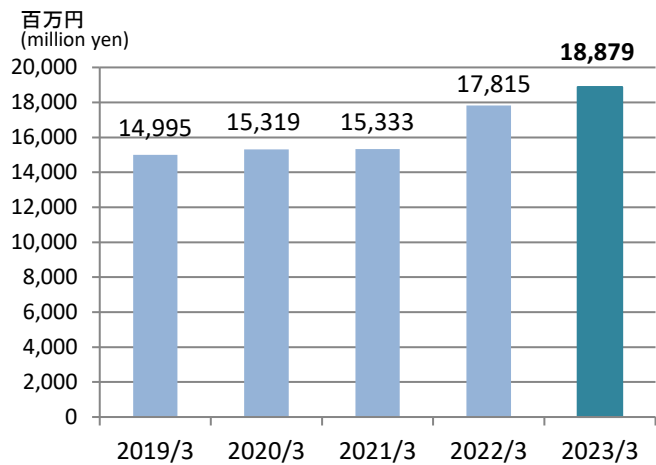

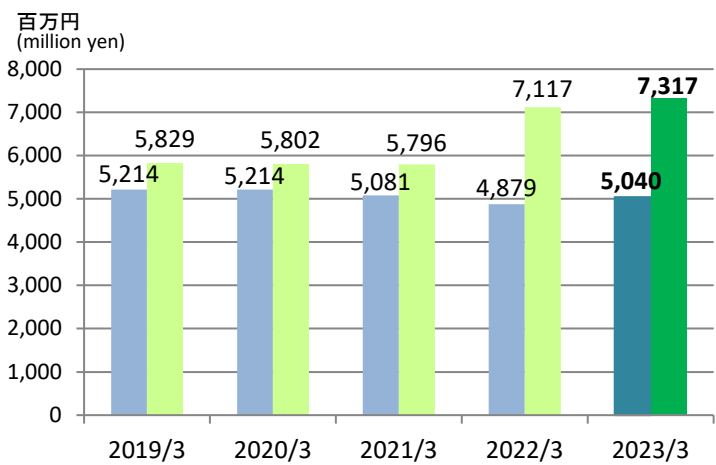

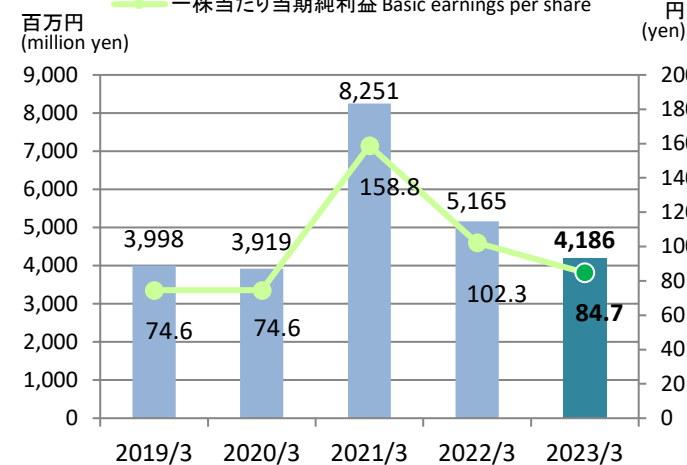

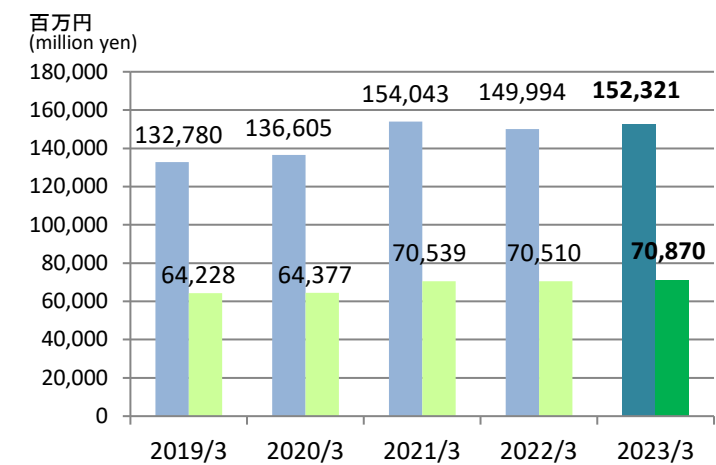

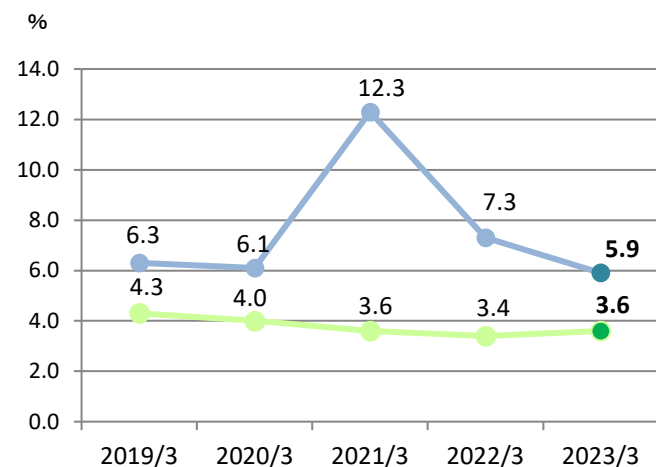

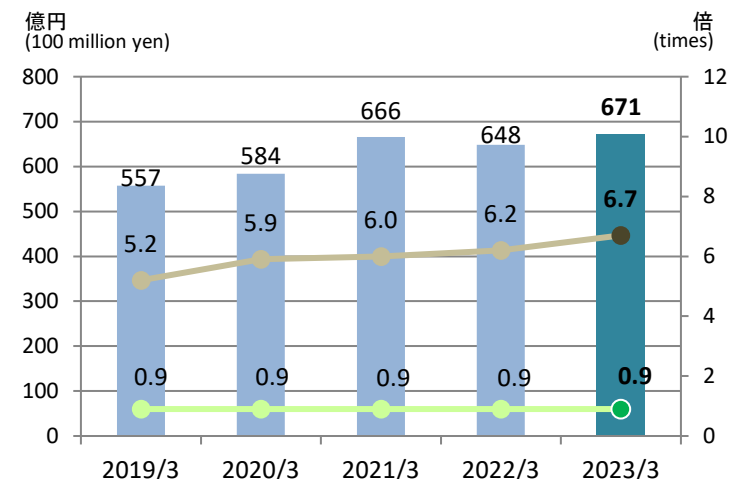

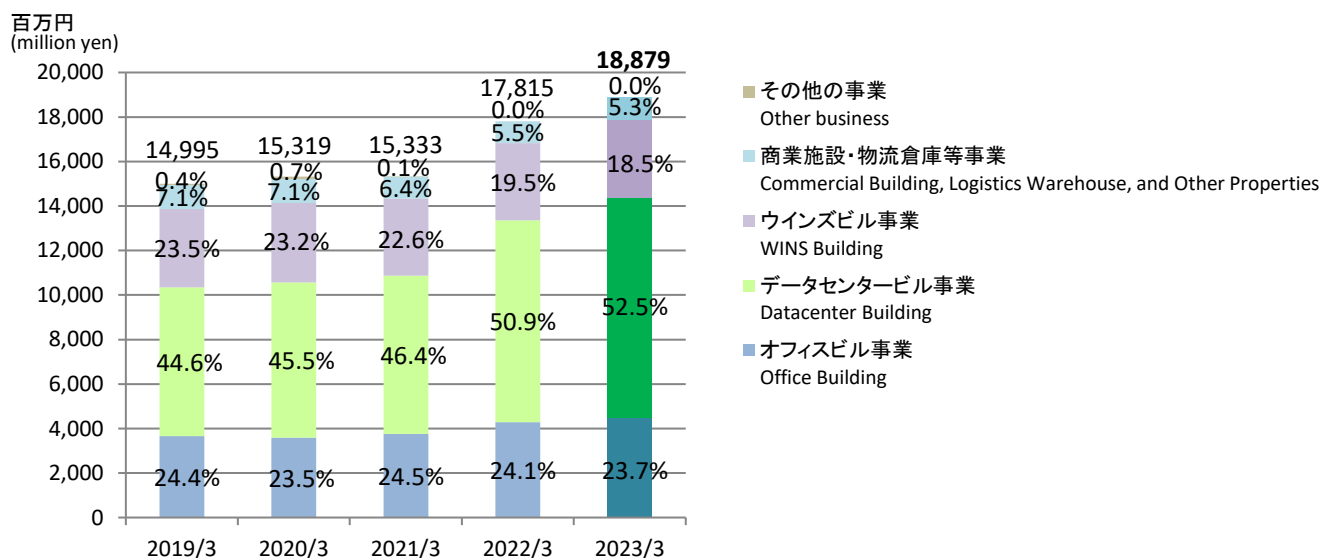

Sales by Business Division



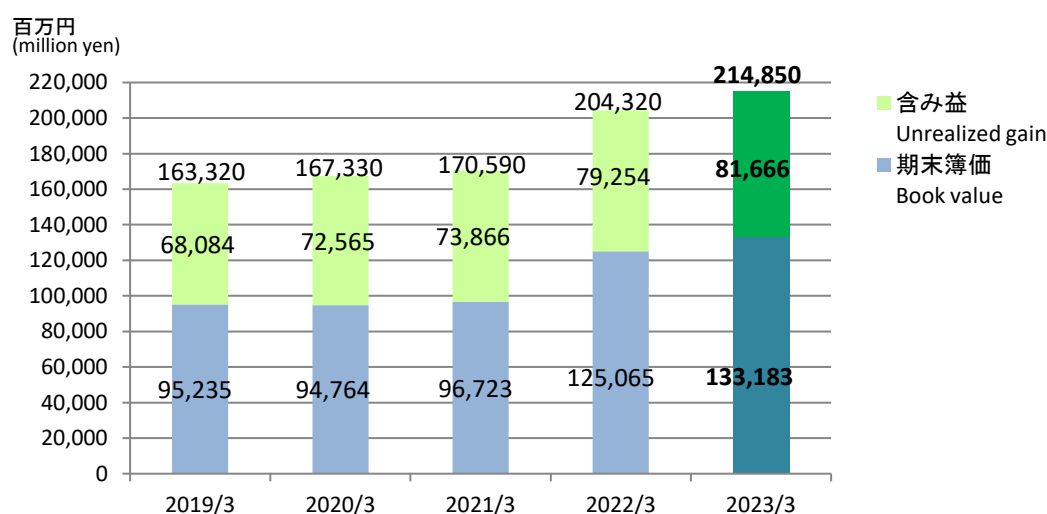

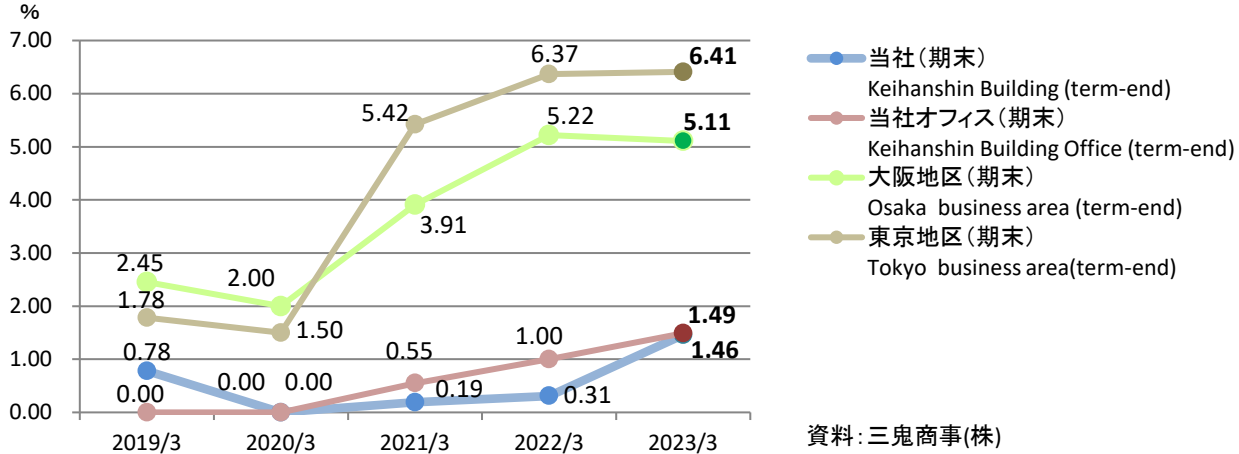

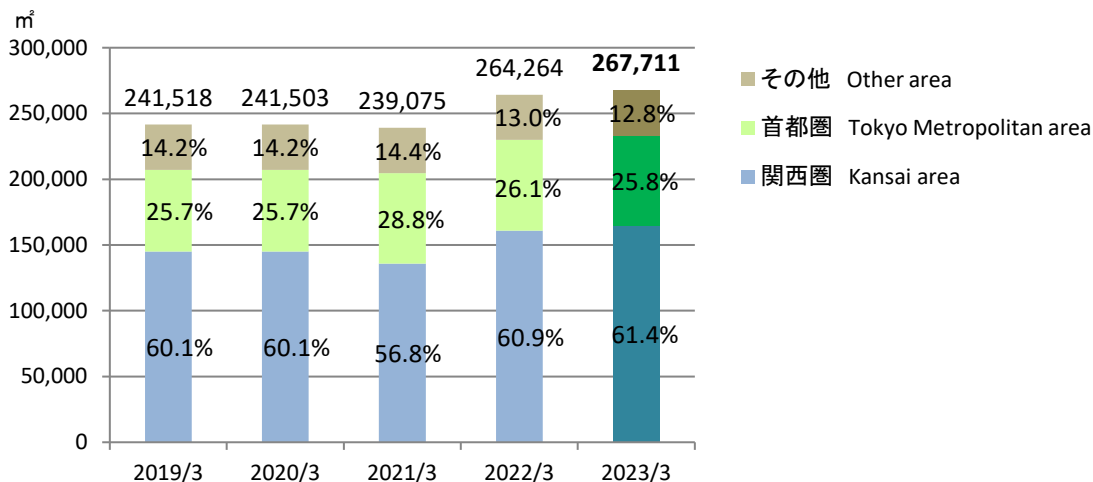
