Changes in Representative Directors (Planned) and in Responsibilities of Executives

URAYASU, CHIBA—Oriental Land Co., Ltd. announces that its Board of Directors has resolved today to make changes to its representative director team following a discussion by the Nomination/Remuneration Committee. The Board of Directors has also resolved today to make changes to the responsibilities of executives as follows.

The decision to make changes to its representative director team will be official upon approval at the Board of Directors meeting to be held after the changes have been approved at the 63rd Annual Meeting of Shareholders scheduled for June 29, 2023.

<Reasons for changes>

The OLC Group has overcome the COVID-19 pandemic to achieve a significant recovery in its financial performance for the fiscal year ended March 2023 compared to the preceding fiscal year. In addition, Tokyo Disney Resort® marked its 40th anniversary in April 2023, for which it attracted a high number of Guests and regained the bustling atmosphere of the pre-COVID period.

In light of such circumstances, the Company has decided to make changes to its representative director team for the purpose of establishing a new management structure for proceeding to the next stage with the aim of further enhancing the corporate value of the Group.

According to the plan, Toshio Kagami will be appointed as the Chairman of the Board of Directors, as in previous years. This is based on the Company's belief that the role of the Chairman of the Board of Directors is not merely to facilitate the proceedings but also to promote sufficient discussion at the Board of Directors

meetings and guide important decision-making, and the position should therefore be assumed by a director who is capable of executing leadership with a full understanding of the Company.

The role of Representative Director, Chairman and CEO is to assume the responsibility of overseeing the Company's overall management. Yumiko Takano, who has been judged as being capable of fulfilling the role, has therefore been newly nominated to the position.

<Reasons for nominating the new representative director>

Yumiko Takano has profound insight, a wealth of experience and a proven track record in the Tokyo Disney Resort business as well as the skills and character befitting a chief executive, who must embody the Company's business mission. Following a discussion at the Nomination/Renumeration Committee, the Company has resolved to nominate her as Representative Director, Chairman and CEO at the Board of Directors meeting, deeming her capable of assuming the Group's overall management in her new capacity.
