Daio Paper Corporation hereby announces that we have resolved at the Board of Directors meeting held on May 12, 2023, to make changes to Representative Directors, etc. and partial change to the announcement "Changes of Directors, etc." dated March 9, 2023.

1. Reasons for Change to the Announcement "Change of Directors, etc."

As the business environment surrounding our Company remains severe, we concluded once again that reform is our priority for this fiscal year to recover our business results early and that it is necessary to accelerate the reform by restructuring our management strategies and reviewing our management structure.

Specifically, in order to (a) further reform the structure centering around domestic and overseas Home & Personal Care Business positioned as our Group's growth driver, (b) optimize procurement of raw materials and fuel such as reduction of coal use and purchase of chips, and (c) strengthen the sustainable management structure and further promote business activities aimed at achieving SDGs, we will change the proposal of Directors as follows.
