(the "Company") hereby announces that it has performed the acquisition of treasury shares that its Board of Directors decided to conduct during a meeting held on May 9, 2023. Shares were acquired in accordance with Article 165, Paragraph 3 of the Companies Act of Japan, which authorizes the Board of Directors of a company to elect to acquire treasury shares through resolution (instead of relying on a resolution passed via a shareholders meeting, as prescribed by Article 156 of the same act) if provisions established within the Company's Articles of Incorporation so allow.
