# 2. Points Recognized in the Certification

The following points were recognized upon receiving certification.

## Hakata FD Business Center (New)

- (1) Energy and resource saving with control of outside air by ventilation hoppers, the installation of human sensors and illumination sensors for LED lights in facilities, and the use of water-saving faucets and toilets.
- (2) Consideration to the comfort and health for residents through the installation of a refreshment room, the woody interior of the entrance hall, and the use of sterilization units in the air conditioning.
- (3) Enhanced by ensuring earthquake resistance 1.25 times that of the Building Standard Law, installing seawalls to prevent flooding, and adopting a two-circuit power receiving system for disaster prevention.
