Notice Concerning Organizational Change of the Asset Management Company

Kenedix Office Investment Corporation (“KDO”), Kenedix Residential Next Investment Corporation (“KDR”) and Kenedix Retail REIT Corporation (“KRR”) has announced today, that the Board of Directors of Kenedix Real Estate Fund Management, Inc. (“the Asset Management Company”), the asset management company for KDO, KDR and KRR, decided an organizational change of the Asset Management Company. Details are as follows.

1. Outline and Purpose of Organizational Change

KDO, KDR and KRR have executed an absorption-type merger agreement (scheduled effective date: November 1, 2023), whereby KDO will be the surviving corporation and KDR and KRR will be the dissolving corporations in the merger (the “Merger”). In line with the Merger, Office REIT Department, which is in charge of asset management operations of KDO, will change its name to Listed REIT Department, and establish separate divisions to manage each asset type. Furthermore, Portfolio Management Department will be newly established to provide a cross-sectional collection, compilation, analysis and review of various data on the real estate managed by the Listed REIT Department, and prepare long-term portfolio management plans / property management plans.

Moreover, Sustainability Office will be changed to Sustainability Department to further commit to sustainability.

2. Effective Date of Organizational Change

November 1, 2023 (Provided that the Merger shall become effective)

Asset Management Company will carry out all necessary filings and other procedures in accordance with the Financial Instruments and Exchange Act, the Real Estate Brokerage Act and other applicable laws and regulations.

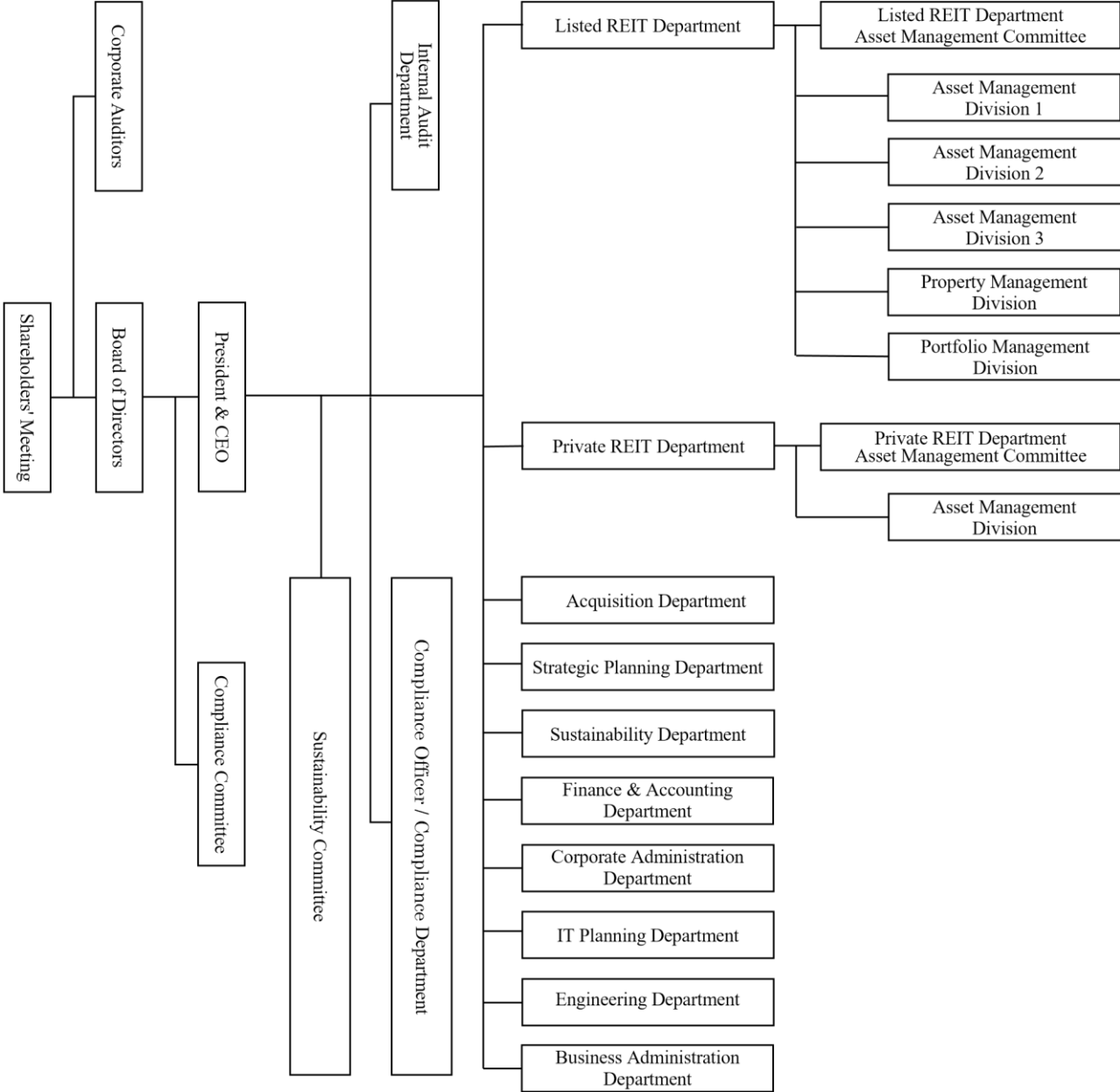
