- ✓ Substantial increases in both net sales and profits compared with the same period of the previous year due to substantial increases in the sales volume of both pachinko machines and pachislot machines.
- ✓ Achieved good progress for the forecasts of financial results for fiscal 2024 due to steady accumulation of the sale volumes of pachinko/pachislot machines.

# Pachinko Pachislot Market

- ✓ In the market for Smart Pachinko/Pachislot machines, with several hit titles emerging, Smart Pachislot machines are diffusing earlier than Smart Pachinko machines because of their more positive contribution on machine utilization.
- ✓ Regarding Smart Pachinko machines, manufacturers have pursued a trial-and-error approach, with certain titles proving to be successful, but full-scale diffusion of Smart Pachinko machines is expected to take a while.
- ✓ Diffusion of Smart Pachislot machines is smoothly progressing as many new titles have been rolled out, generating some hits.

# SANKYO Group

- Number of New Titles of Pachinko machine released: Five (Reused models etc.: Five)
- Number of New Titles of Pachislot machine released: Three
- ✓ The sales volumes of both pachinko and pachislot machines increased due to brisk sales of new titles and series products, led by sales of 50,000 units of Fever MOBILE SUIT GUNDAM SEED .
- ✓ The Group implemented the change in dividend policy and the repurchase of the Company's own shares.



## **Factors of Change in Consolidated Net Sales**





- ✓ Total sales volume in the period from April to September, 2023 fell short of the same period of the previous year.
  - Stagnant machine utilization is seen due to a lack of new titles to drive machine utilization.
  - Regarding Smart Pachinko machines, the differentiation of gaming performance from conventional pachinko machines is an issue. Therefore, full-scale diffusion of Smart Pachinko machines is expected to take a while.
- ✓ Increasing the number of hit titles to drive machine utilization becomes the key.
  - Among Smart Pachinko titles released, a hit title emerged.

    More emergences of hit title of Smart Pachinko is expected.
  - Increasing the number of hit titles is an urgent issue, regardless conventional pachinko machines or Smart Pachinko machines.



- ✓ Total sales volume in the period from April to September, 2023 exceeds the same period of the previous year.
  - The pachislot machines sales market has been buoyant against the backdrop of brisk machine utilization.
  - The rate of Smart Pachislot machines in the pachislot market increased up to approximately 20%.
- Strong demand, centered on the popular titles, is expected to continue from the Q3 onward.
  - Buyont demand will be expected due to the release of successor of popular titles of Smart Pachislot titles.
  - We revise the forecast of the total sales volume in pachislot market from 750 thousand units, assumed at initial forecast, to 800 thousand units,


#### Change in the Dividend Policy (announced on September 21, 2023)



#### < New Dividend Policy >

The Company's basic policy is to pay performance-linked dividends with a consolidated dividend payout ratio of 40% as a benchmark. However, the minimum annual dividend per share shall be set at ¥100 to maintain stable dividends. For the interim dividend, a consolidated dividend payout ratio of 40% for the first six months of the fiscal year shall be the benchmark for the total dividend amount, but the interim dividend shall be no more than 50% of the forecast full-year dividend per share at the time the interim dividend amount is determined.






