Notice of Revision to the Dividend Forecast

Japan Elevator Service Holdings Co., Ltd. (the “Company”) announces that at the meeting of the Board of Directors held today a resolution was passed to revise the forecast for the year-end dividend for the fiscal year ending March 31, 2024 as follows.

1. Reasons for the revision

The Company recognizes that returning profits to shareholders is one of its most important management policies, and its basic policy is to maintain stable dividends while securing the internal reserves necessary to strengthen its management base in response to changes in the business environment and for future business development.

Based on the above policy, the year-end dividend for the fiscal year ending March 31, 2024, which had previously been undecided, will be ¥23.00 per share, taking into consideration the business results for the current fiscal year and future business development.
