Progress of Acquisition of Treasury Stock

Tokyo, February 1, 2024 ----- Wacom Co., Ltd. (the "Company") announces the progress of acquisition of its treasury stock pursuant to Article 156 of Japanese Companies Act, of which application is defined by both paragraph 1, Article 459 of the Companies Act and provisions of the Company's Articles of Incorporation, as follows.

1. Details of acquisition completed

- (1) Type of shares acquired: Common stock of the Company
- (2) Total number of shares acquired: 1,750,800 shares
- (3) Total acquisition cost: 1,184,114,300 Japanese yen
- (4) Acquisition period: From January 1, 2024, to January 31, 2024 (on a trade basis)
- (5) Acquisition method: Open market acquisition of shares on the Tokyo Stock Exchange

1. Details of the resolution at the meeting of the Board of Directors held on October 31, 2023

- (1) Type of shares to be acquired: Common stock of the Company
- (2) Total number of shares to be acquired: Up to 13,000,000 shares
Equivalent to 8.41% of outstanding shares (excluding treasury stock)
- (3) Total acquisition cost: Up to 6.5 billion Japanese yen
- (4) Acquisition period: From November 1, 2023 to March 29, 2024
- (5) Acquisition method: Open market acquisition of shares on the Tokyo Stock Exchange

2. Total shares acquired as of January 31, 2024 pursuant to the above resolution at the meeting of the Board of Directors

- (1) Total number of shares acquired: 5,153,800 shares
- (2) Total acquisition cost : 3,534,968,500 Japanese yen
