### Notice Concerning the Securing of Preferential Negotiation Rights for Property Acquisition

Advance Logistics Investment Corporation (“ADL”) hereby announce that we have acquired the right to preferentially negotiate the sale (“Preferential Negotiation Right”) and purchase of T&B Maintenance Center Toyama (“the Property”) as follows.

#### 1. Overview of the Preferential Negotiation Rights

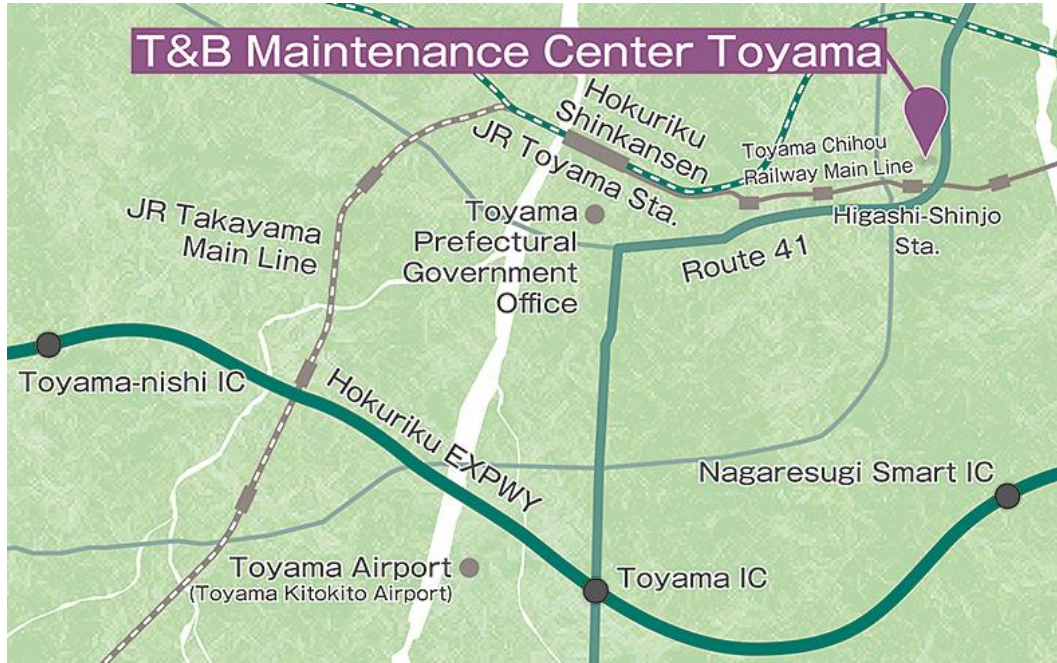

The acquisition price, timing, etc. of the Property have not yet been determined. In acquiring the Property, a decision will be made after conducting the necessary due diligence. Although ADL has been granted Preferential Negotiating Right for the Property, it is not necessarily able to acquire the property, nor is it obligated to acquire the Property. In addition, no consideration will be paid to the party from which the Preferential Negotiating Right is acquired.

#### 2. Reasons and background for acquisition of Preferential Negotiating Rights

We believe that this acquisition will have the effect of significantly contributing to ADL's future external growth, providing more flexibly and secure properties from a variety of sources by utilizing the own network of ITOCHU REIT Management Co., Ltd. (the “Asset Manager”), in addition to the conventional acquisition of pipeline properties from the sponsors. The Property is a directly managed service plant of a major truck and bus manufacturer located in the center of Toyama City, a core city with a population of approximately 400,000 in the Hokuriku area. As a real estate used as a base or infrastructure for business activities, the Property has stable profitability, and the land with high versatility that can be used for various purposes is rare, and we believe that the Property will diversify the portfolio of ADL. With this acquisition, ADL will secure further opportunities to acquire properties in the future, and aims to achieve external growth and increase unitholder value by acquiring this property at the appropriate time in the future.
