# Notification of Conclusion of Product License Sale Agreement and Investment Agreement with Whale Dynamic

Kudan Inc. (headquarters in Shibuya-ku, Tokyo; CEO Daiu Ko; including its subsidiaries, hereafter "Kudan") is pleased to announce that today it has concluded a product license sale agreement and an investment agreement (the "Agreements") with Whale Dynamic Co., Ltd. (Chinese: 深圳市惠爾智能有限公司; headquartered in Shenzhen, China; CEO: David Yufei Chang; including its group companies, hereafter "Whale Dynamic"), Kudan's business partner which develops autonomous driving solutions in China.





## 1. Background and reasons for the Agreements

As notified in our September 20, 2023 press release "Notification of Conclusion of Memorandum of Understanding for a Capital and Business Alliance, Including the sales of Product Licenses Totaling 300-400 Million Yen to Whale Dynamic" Kudan concluded a memorandum of understanding on the same date for a capital and business alliance with Whale Dynamic. Also, as notified in our November 14, 2023 press release "Notification of Agreement on Main Terms of Product License Sale Agreement and Investment Agreement with Whale Dynamic", Kudan has reached a binding agreement on the same date on the main terms of a product license sale agreement and investment agreement with Whale Dynamic.

In accordance with the agreement, Kudan subsequently continued specific discussions of the detailed conditions of the Agreements and further expansion of the partnership, reaching the conclusion of the Agreements.

As a result, in this fiscal year (FYE March 2024), Kudan is selling product licenses worth 240 million yen to Whale Dynamic in order for Whale Dynamic to meet the increased demand for its solutions from its two-pronged global regional expansion and product expansion, including autonomous driving for passenger cars as well as mapping and robots (autonomous mobile vehicles) in global regions such as Europe and the Middle East, as well in the Chinese market, where it has already been expanding its track record.

In addition, Kudan will invest 400 million yen in the Whale Dynamic and continue to strengthen our collaborative structure and jointly promote the sales of Whale Dynamic's products and the spread of Kudan's technology.

## 2. Details of the Agreements

The details of the Agreements concluded by Kudan and Whale Dynamic are as follows.

- Main terms of the product license sale agreement
  Kudan will sell product licenses to Whale Dynamic group worth 240 million yen.
- (2) Main terms of the investment agreement Kudan will invest 400 million yen (8% of the total outstanding shares) in the Whale Dynamic group.

Going forward, based on the Agreements, we plan to complete the transactions in February-March 2024. We will also examine the conclusion of additional product license sale agreements and investment agreements depending on the progress of the business and collaboration structure of both parties. We will promptly announce any resolution to conclude additional agreements.
