Announcement Regarding the Status of Repurchase of Own Shares

(Repurchase of the Company's shares in accordance with the Articles of Incorporation under
Article 165, paragraph 2 of the Companies Act)

ITOCHU Corporation ("ITOCHU") decided at the meeting of the Board of Directors held on November 6, 2023 to repurchase own shares in accordance with Article 156 of the Companies Act of Japan, as applied pursuant to Paragraph 3, Article 165 of the Companies Act of Japan. ITOCHU hereby announces the status of the repurchase as follows.

1. Progress of the repurchase until January 31, 2024
 - (1) Type of shares repurchased: Common stock of ITOCHU
 - (2) Total number of shares repurchased: 3,111,600 shares
 - (3) Total amount: 20,101,395,600 yen
 - (4) Period: From January 1, 2024 to January 31, 2024

2. Accumulated total of the repurchase until January 31, 2024 pursuant to the above resolution
 - (1) Total number of shares repurchased: 9,104,100 shares
 - (2) Total amount of shares repurchased: 55,156,568,800 yen
