Notice of Changes in Representative Director of the Company and in Director and Audit & Supervisory Board Member of Consolidated Subsidiary (AGEST, Inc.)

DIGITAL HEARTS HOLDINGS Co., Ltd. (hereinafter referred to as the "Company") has announced that the change in the Representative Director of the Company on April 1, 2024, and the change in Director and Audit & Supervisory Board Member of consolidated subsidiary, AGEST, Inc. ("AGEST") on March 26, 2024 were approved at the meeting of its board of directors held today.

1. Reasons for the Change in Representative Director

As disclosed on May 11, 2023 in the "Notice of Commencement of Preparations for the Share-Distribution-Type Spin-Off and Commencement of Preparations for Listing the Shares of AGEST, Inc., Our Consolidated Subsidiary", the Company has begun preparations for AGEST's share-distribution-type spin-off and listing ("Spin-Off Listing"), its wholly owned subsidiary. Since May 2023, we have made steady progress in preparing for Spin-Off Listing, including the establishment of AGEST's own head office functions and the implementation of a group-wide reorganization in anticipation of Spin-Off Listing by the end of 2025. As part of a preparation, we have resolved the new management structure that includes the change in Representative Director of the Company.

Yasumasa Ninomiya, who is the current Representative Director of both the Company and AGEST, will concentrate on the management of AGEST group after this change of the management. In addition Eiichi Miyazawa, the founder of the Company, will assume the Representative Director and Chairman of the Company, and Toshiya Tsukushi, who serves as Representative of its Entertainment Business's core subsidiary, DIGITAL HEARTS Co., Ltd., will assume the Representative Director and President of the Company, to deeply strengthen our game debugging services and rapidly develop our global businesses and further new services.

Going forward, under this new management structure, we will aim to achieve sustainable growth and increase corporate value for both businesses.
