## Ichigo Selected for CDP 2023 Climate Change A List

Ichigo has been selected for the A List in the 2023 Climate Change Assessment by CDP, a non-profit organization that promotes global environmental reporting.

### 1. About CDP

CDP is a global non-profit organization that runs the world's environmental disclosure system and assesses companies on their environmental transparency and actions. An assessment questionnaire spanning topics such as governance, risk management, business strategy, targets and performance, and engagement is used to score companies among eight levels: Leadership (A/A-), Management (B/B-), Awareness (C/C-), and Disclosure (D/D-).

### 2. Assessment Results

CDP's Climate Change A List includes companies leading the way in environmental transparency and performance on climate change. Of the 23,000 participating companies in 2023, 346 companies were recognized as A List companies, of which 109 were Japanese companies including Ichigo.

Ichigo also received an A- score and the highest Leadership level in the CDP Water Security Assessment.
