In addition, the new Representative Director is scheduled to be officially appointed at the 90th Ordinary General Meeting of Shareholders to be held on June 26, 2024 and at the Board of Directors meeting after the General Meeting of Shareholders.

## 2. Reason for the change

The Company started its 3rd Medium-Term Management Plan this fiscal year to commemorate our 100th anniversary in FY2027. In terms of profit and loss, a downward revision was made for the full-year forecasts for the fiscal year ending March 31, 2024 as explained in "Notice of revision to full-year financial results forecasts" published on November 13, 2023 mostly due to the deterioration of gross profit in the electricity business. Against this background, the decision was made to renew our management system to both clarify management responsibility and increase our ability to achieve the 3rd Medium-Term Management Plan.

The Company's President Mr. Yamazaki will step aside from the position of President and take up the role of Chairman following a resolution at the 90th Ordinary General Meeting of Shareholders and the Board of Directors meeting after the General Meeting of Shareholders. The Company's Senior

Managing Director Mr. Shimizu will also resign from the position of Company Director.

In addition, Mr. Yamazaki will continue to have the right of representation to promote matters that are in progress, and he will return the right of representation when we have reached the goal of making progress with matters and have developed the foundations for the new management system.

Under the new management system, Mr. Nakagome will direct the overall management of the Group as the President and CEO (Chief Executive Officer) while Mr. Yamazaki will provide support for the new management system to create a system that clarifies each individual's responsible roles.

From now, the Company will work together as a group under the new management system with the aim of sustainable growth and improved corporate value as we head towards our 100th anniversary in FY2027.
