Notice Concerning Changes in Organization, Changes in Representative Corporate Executive Officers and Other Personnel

Mitsubishi Estate Co., Ltd. (hereafter "Mitsubishi Estate" or "the Company") hereby announces that it has decided to make the following organizational changes: changes in Representative Corporate Executive Officers and other personnel as well as candidates for Directors to be submitted at the Ordinary General Meeting of Shareholders scheduled to be held in the latter half of June 2024, and candidates for committee members of the Nominating Committee, Audit Committee and Remuneration Committee to be submitted at the Board of Directors' Meeting to be held after the Ordinary General Meeting of Shareholders.

I. Organizational Changes

[Effective as of April 1, 2024]

To accelerate initiatives aimed at achieving Long-Term Management Plan 2030, the Company will make the following organizational changes in light of changes to the business environment and results over the four years since the plan was formulated.

1. Reorganization of Business Groups

(1) Launch of Marunouchi Property Business Group

To achieve Long-Term Management Plan 2030, which was formulated in January 2020, the Company intended to demonstrate collective strength beyond asset-type boundaries, strengthen the acquisition of high value-added business opportunities combined with the non-asset business and make efficient and high-level business decisions. To that end, the Company established the Commercial Property Business Group in April 2020 as the organization responsible for the development and operation of real estate (excluding residential) in Japan and general related business activities. However, due to changes to the business environment and other factors that developed since that time, the Company will review and make changes to its current business groups, reflecting the need to plan and execute dynamic strategies based on business models, and the growing need for organizational design catering to proactive initiatives targeting new asset types and operational assets.

Specifically, once the Marunouchi Property Business Group has been newly established, the organizations handling functions related to the Otemachi-Marunouchi-Yurakucho area will be transferred to it, and the current Commercial Property Business Group will be split into a new iteration

- 2. Organizational Changes Within Function-Based Groups and Business Groups
 - (1) Business Development, Client Relations & Solutions Group
 - ① Launch of Office Leasing and Tenant Relations Department 2
 With the aim of enhancing sales functions, once Office Leasing and Tenant Relations Department
 2 will be established, the functions and other aspects of the Office Leasing and Tenant Relations
 Department will be transferred to it.
 - ② Renaming the Office Leasing and Tenant Relations Department to Office Leasing and Tenant Relations Department 1
 - The Office Leasing and Tenant Relations Department will be renamed to Office Leasing and Tenant Relations Department 1 in line with the new establishment of Office Leasing and Tenant Relations Department 2.
 - ③ Reallocation of Relocation Management Office The Relocation Management Office of the Office Leasing and Tenant Relations Department will be transferred to Office Leasing and Tenant Relations Department 2 in line with the new establishment of Office Leasing and Tenant Relations Department 2.

(2) Commercial Property Business Group

- ① Japanese name of Commercial Property Management Department has renamed.※
 - *The English name remains unchanged. Therefore, to differentiate, the department name up to this fiscal year will be referred to as "post-Commercial Property Management Department" from now on.
 - Once asset management functions and other aspects during the asset holding period related to the Otemachi-Marunouchi-Yurakucho area handled by the post-Commercial Property Management Department have been transferred to the Marunouchi Property Management Department, Japanese name of the post-Commercial Property Management Department will be renamed to the Commercial Property Management Department.
- ② Renaming the Commercial Property Business Strategy Department to Business Development Planning Department
 - With the aim of strengthening functions to create business opportunities for new asset types in the Commercial Property Business Group and develop business opportunities related to strategic real estate, the strategy planning functions of the Commercial Property Business Strategy Department will be transferred to the Marunouchi Property Business Planning Department and Commercial Property Business Planning Department, which will then be renamed to the Business Development Planning Department.
- ③ Integration of the Mixed Use Development Department into the Urban Project Development Department
 - With the aim of consolidating large mixed-use development projects outside the Otemachi-Marunouchi-Yurakucho area as well as development functions for real estate such as buildings and commercial facilities, the Mixed Use Development Department will be integrated into the Urban Project Development Department.
- 4 Launch of Kamiseya Business Planning Office The Kamiseya Business Planning Office will be established in the Commercial Property Business Group in line with the expanding business of the Kamiseya Planning Office of the Yokohama Branch.

(5) Renaming the Retail Property Strategy & Marketing Planning Office to Retail Property Business Office

With the aim of enhancing facility planning support related to commercial facilities and other properties, and strengthening planning, research and other functions, the Retail Property Strategy & Marketing Planning Office under the post-Commercial Property Management Department will be renamed to the Retail Property Business Office.

6 Launch of Nihonbashi and Yaesu Development Office

The Nihonbashi and Yaesu Development Office will be established within the Urban Redevelopment Department, as an organization handling planning, drafting, implementation and consulting services for urban redevelopment project and other projects in the Nihonbashi, Yaesu and surrounding areas, as well as asset management over the term of development projects.

7 Launch of Shibuya Development Office

The Shibuya Development Office will be newly established within the Urban Redevelopment Department, as an organization handling planning, drafting, implementation and consulting services for urban redevelopment project and other projects in the Shibuya and surrounding area, as well as asset management over the term of development projects.

The Shinjuku Development Office will be established within the Urban Redevelopment Department, as an organization handling planning, drafting, implementation and consulting services for urban redevelopment project and other projects in the Shinjuku and surrounding area, as well as asset management over the term of development project.

(3) Marunouchi Property Business Group

① Launch of Marunouchi Property Business Planning Department
The Marunouchi Property Business Planning Department will be established as an organization
with responsibility for line staff business functions related to the Otemachi-Marunouchi
Yurakucho area handled by the Commercial Property Business Planning Department and the
strategy planning functions related to the Otemachi-Marunouchi-Yurakucho area handled by the
Commercial Property Business Strategy Department.

② Launch of Marunouchi Property Management Department

The Marunouchi Property Management Department will be newly established as an organizational that will be responsible for asset management functions during the asset holding period related to the Otemachi-Marunouchi-Yurakucho area handled by the post-Commercial Property Management Department.

③ Reallocation of Area Management Planning Department, Content Business Planning and Operation Department, Flexible Workspace Planning and Operation Department, Museum Management Office, Urban Planning Department, Urban Energy Strategy Planning Department and TOKYO TORCH Department

The following organizations handling functions related to the Otemachi-Marunouchi-Yurakucho area will be transferred from the Commercial Property Business Group to the Marunouchi Property Business Group.

- Content Business Planning and Operation Department
- Flexible Workspace Planning and Operation Department

With the aim of clustering growing companies in the Otemachi-Marunouchi-Yurakucho area through support and other activities aimed at startups and other growing companies, while strengthening operating functions for facilities that promote innovation on the part of Mitsubishi Estate and tenants, xTECH Leasing and Promotion Department will be renamed to Innovative Communities Department, and then transferred from the Commercial Property Business Group to the Marunouchi Property Business Group.

- (5) Launch of Marunouchi Development Department
 As an organization responsible for development functions related to the Otemachi-MarunouchiYurakucho area handled by the Mixed Use Development Department, the Marunouchi
 Development Department will be newly established.
- ® Reallocation of OCA TOKYO Business Promotion Office With the aim of improving earnings in the Otemachi-Marunouchi-Yurakucho area by spreading information about the appeals of the area through activities at OCA TOKYO, clustering startups and other growing companies and creating new added value and other advancements based on membership (B-to-C) businesses, the OCA TOKYO Business Promotion Office will be transferred to the Innovative Communities Department.

(4) International Business Group

① Launch of Investment Screening Office

With the aim of enhancing governance functions when considering investments by the International Business Group, the Investment Screening Office will be newly established within the International Business Planning Department as an organizational responsible for investment screening functions and other activities.

(5) Other

① Internal Audit Office renamed to Internal Audit Department
In light of the growing important of internal audits in corporate governance due to changes to the business environment and other factors, the Internal Audit Office will be renamed to the Internal Audit Department.
