1. Qualitative Information on Quarterly Financial Results

(1) Explanation of Operating Results

During the first nine months of the current fiscal year, the Japanese economy was supported by upturns in consumer spending, capital expenditures and employment and other positive trends in social activities. However, the outlook remains uncertain as there is still a risk of an economic downturn due to the prolonged weakness of the yen, high prices of materials and resources, concerns about the outlook for the Chinese economy, and the conflicts in the Middle East and Ukraine.

In the construction industry, which is the main source of demand for our products, construction investments were generally stable, amounting to ¥37 trillion between April and November 2023 (up 2.4% year on year), according to "Comprehensive Construction Statistics" published by the Ministry of Land, Infrastructure, Transport and Tourism. However, according to "Building Starts Statistics" by the said ministry, the number of residential and non-residential construction starts during the same period decreased 6.6% from one year earlier to 594,496 and the total floor area of construction starts was down 10.2% to 70,249 thousand square meters. Although construction investments increased, the level of construction starts is low. This is mainly the result of the high cost and shortage of building materials as well as the shortage of construction workers and rising wages for these workers. The Japanese government is firmly committed to making consistent and rapid progress with measures to increase the country's resilience to natural disasters as unusual weather events become increasingly severe and frequent. Furthermore, large urban redevelopment projects are likely to continue for many more years.

In this difficult business climate, there were many activities for generating sales that included proposals to customers that combine purchases and rentals of scaffolding for more flexibility. In addition, we made progress with preparations for increasing sales in categories where long-term demand growth is expected and of new products for projects for resilience to natural disasters. For example, we continued to supply our multilevel linked scaffolding, which is ideal for high-rise buildings, and started selling and renting Rapid FloorTM, a suspended system scaffold that was developed with a large bridge construction company and construction equipment leasing company.

In the Logistics Equipment Division, there was a decline in orders even though demand is generally recovering. The main reason is variations in different industries regarding the volume and timing of the required equipment. A delay in the recognition of sales resulting from a large logistics warehouse order also affected the performance of this division. Sales activities are aimed at adding more market sectors for logistics equipment by identifying opportunities involving demand and projects in industries not yet served by this division.

Activities to hold down expenses are continuing. To maintain sound relationships with partner companies and a production framework capable of restoring the volume of products we supply, we responded to requests from these companies to revise prices. Selling, general and administration expenses decreased because of a big downturn in shipping and delivery expenses due to the smaller volume of products shipped. To maintain the soundness of our organization, we increased expenditures and benefits for employees. There were also expenses for the start of a shareholder benefit program as part of measures to distribute earnings to shareholders.

As a result, revenue for the first nine months decreased 20.2% from one year earlier to ¥9,675 million. Operating profit was down 50.0% to ¥694 million, profit before tax was down 50.9% to ¥656 million, and profit attributable to owners of parent was down 52.9% to ¥439 million.

The following section explains the performance of business divisions because the Shinwa Group has one business segment.

1) Scaffolding Equipment Division

Customers are continuing to rent rather than purchase scaffolding equipment because of the high prices of materials and products and the rising wages for construction workers since the third quarter of the previous fiscal year. There are also challenges due to postponements and delays of construction projects caused by the shortage of construction workers. Although the demand for scaffolding equipment is stable, some customers are pushing back purchases of wedge binding type scaffolding. In addition, the sales volume decreased year on year because there was a large volume of purchases in the first nine months of the previous fiscal year prior to price revisions.

Sales in this division have been recovering primarily because of the large volume of scaffolding rentals since October and strong demand for next-generation scaffolding. However, a large order that was expected earlier in the fiscal year has been delayed to the fourth quarter.

As a result, revenue for the first nine months in the Scaffolding Equipment Division decreased 15.3% to ¥7,182 million.

2) Logistics Equipment Division

The Logistics Equipment Division received orders, primarily for large logistics warehouse equipment and other repeat projects, steadily during the first nine months because of a higher level of production in many industries. Sales decreased because of a decline in the volume of orders for bulk containers for shipping liquids and the delay to the fourth quarter of one-time sales of products for large logistics warehouses, the transportation of materials for electrical equipment and other applications.

(2) Explanation of Financial Position

(Assets)

Current assets at the end of the third quarter of the current fiscal year decreased by ¥378 million from the end of the previous fiscal year to ¥7,583 million, mainly due to factors such as a decrease in cash and cash equivalents of ¥409 million and a decrease in inventories of ¥303 million despite an increase in trade and other receivables of ¥267 million. Non-current assets decreased by ¥44 million from the end of the previous fiscal year to ¥13,287 million. As a result, total assets decreased by ¥423 million from the end of the previous fiscal year to ¥20,871 million.

(Liabilities)

Current liabilities at the end of the third quarter of the current fiscal year decreased by \$2,163 million from the end of the previous fiscal year to \$3,078 million, mainly due to factors such as a decrease in borrowings of \$2,752 million due to the refinancing of the syndicated loan. Non-current liabilities increased by \$1,952 million from the end of the previous fiscal year to \$2,453 million, mainly due to factors such as an increase in borrowings of \$1,960 million due to the refinancing of the syndicated loan. As a result, total liabilities decreased by \$210 million from the end of the previous fiscal year to \$5,532 million.

(Equity)

Total equity at the end of the third quarter of the current fiscal year decreased by ¥213 million from the end of the previous fiscal year to ¥15,339 million. This was mainly attributable to factors such as the posting of profit attributable to owners of parent of ¥439 million and dividends paid of ¥667 million.

(3) Overview of Cash Flows

Cash and cash equivalents (hereinafter "cash") at the end of the first nine months of the current fiscal year was \\frac{\pma1}{0.654}\$ million, a decrease of \\\frac{\pma409}{0.654}\$ million from the end of the previous fiscal year.

Cash flows from each activity for the first nine months of the current fiscal year and their primary factors are as follows:

(Cash flows from operating activities)

Net cash provided by operating activities for the first nine months of the current fiscal year was ¥1,529 million, an increase of ¥1,366 million year on year. Main factors affecting cash inflows were profit before tax of ¥656 million, an increase in trade and other payables of ¥563 million, depreciation and amortization of ¥434 million and a decrease in inventories of ¥303 million. The main factors affecting cash outflows were income taxes paid of ¥351 million and an increase in trade and other receivables of ¥269 million.

(Cash flows from investing activities)

Net cash used in investing activities for the first nine months of the current fiscal year was \$396 million, a decrease of \$198 million year on year. The main factors affecting cash outflows were purchase of property, plant and equipment of \$390 million.

(Cash flows from financing activities)

Net cash used in financing activities for the first nine months of the current fiscal year was \(\pm\)1,543 million, an increase of \(\pm\)453 million year on year. Main factors include proceeds from long-term borrowings of \(\pm\)2,500 million due to the refinancing of the syndicated loan and repayments of long-term borrowings of \(\pm\)3,250 million.

(4) Explanation of Consolidated Financial Results Forecast and Other Forward-Looking Information

There are no revisions to the fiscal year forecast for consolidated sales and earnings that was announced on May 12, 2023, because examinations are under way concerning the outlook for changes in market conditions and results of operations. An announcement will be made promptly if any revisions are needed.
