Notice Regarding Determination of Candidates for Directors after the Transition to a Company with an Audit and Supervisory Committee and New Management Structure

As announced in the "Notice of Transition to a Company with an Audit and Supervisory Committee and Partial Amendments to the Articles of Incorporation" dated February 14, 2024, AnyMind Group Inc. ("the Company") plans to transition to a company with an Audit and Supervisory committee, subject to approval at the 5th Ordinary General Meeting of Shareholders scheduled to be held on March 29, 2024. Accordingly, the Board of Directors, at a meeting held today, has informally determined candidates for directors after the transition to a Company with an Audit and Supervisory Committee as outlined below. Please note that this decision will be formalized upon approval at the 5th Ordinary General Meeting of Shareholders scheduled for March 29, 2024.

Details are as follows.

1. Overview

In order to further strengthen the auditing and supervisory functions of the Board of Directors and enhance governance, the Company has resolved to separate management supervision and execution, and transition to a new management execution structure. With this resolution, the Company will implement a new composition of the Board of Directors and the transition to the new management execution structure, conditional upon the approval and adoption of the proposed director candidates at the 5th Ordinary General Meeting of Shareholders.

2. Determination of Director Candidates
