Notice Concerning Cancellation of Treasury Shares

Ushio Inc. announced today that, at the Board of Directors meeting held on March 4, 2024, a resolution was passed to cancel its treasury shares under Article 178 of the Companies Act.

- 1. Type of shares to be canceled: Common shares
- 2. Total number of shares to be canceled: 16,000,000 shares (This number represents 12.95% of total number of issued shares before cancellation)
- 3. Scheduled cancellation date: March 25, 2024
