## Notice of Change of Representative Directors and Management Structure

ALPS ALPINE CO.,LTD. hereby announce that our Board of Directors has decided at a meeting held on March 25, 2024 to review our management structure effective June 26, 2024.

As announced at the financial results briefing for the third quarter of the fiscal year ending March 31, 2024, the Company has suspended its medium-term management plan ending in FY2024, and is proceeding with various measures, concentrating on management structure reforms centered on changes in its business portfolio and cost structure.

In order to carry out these management structural reforms with sufficient depth and without delay under the direction of the CEO, the positions of COO (Chief Operating Officer) and CStO (Chief Strategy Officer) will be newly established. In addition, the roles of each executive officer in management structural reform will be clarified, and the executive officer in charge of production, who will be responsible for worldwide site structural reform, will be promoted to the position of managing executive officer.

On the other hand, the newly established COO (who is scheduled to assume the position of representative director after approval at the annual shareholders meeting scheduled in June of this year and the subsequent board of directors meeting) will be given significant authority over the execution of the company's existing businesses, enabling the CEO to focus more on promoting management structural reforms.
