Notice Concerning Election of Important Employee at the Asset Management Company

NIPPON REIT Investment Corporation ("NIPPON REIT") announces that SBI REIT Advisors Co., Ltd. ("SRA"), which is the asset management company of NIPPON REIT has decided to appoint important employee as below.

1. Reasons for the election of the important employee

To date, SRA has adopted a system for making investment decisions, with one deputy senior general manager of the Investment Management Division serving as CIO (Chief Investment Officer) is an important employee. Effective April 1, 2024, the Company will shift to an organizational structure in which NIPPON REIT's portfolio management is implemented by the Investment Management Department and the Asset Management Department. Accordingly, two deputy senior general managers will be assigned to the Investment Management Division. With two CIO, the deputy general managers of the respective divisions are in charge, and a joint CIO system has been adopted in which both CIO jointly implement investment decisions. Investment management is conducted under the cooperation and mutual checks and balances between the two divisions of the Investment Management Department and the Asset Management Department.

2. Brief history of the joint CIO

A career summary of both joint CIO is as shown in the attached document.

3. Schedule of appointment of important employee

The appointment of important employee and the associated joint CIO system will be implemented on April 1, 2024.

4 Others

Regarding of the above change will be taken in accordance with the provisions of the Financial Instruments and Exchange Act and the Building Lots and Buildings Transactions business Act and other applicable laws and regulations.



5. Future Outlook

The forecast of the management status for fiscal period ending June 2024 (from January 1, 2024 to June 30, 2024) and fiscal period ending December 2024 (from July 1, 2024 to December 31, 2024) announced in the "Summary of Financial Results for the Fiscal Period Ended December 31, 2023 (REIT)" dated February 19, 2024 remains unchanged as the impact will be minimal.
