Announcement on the Change of Executives

We are pleased to announce that at the meeting of the Board of Directors held today, we resolved to change executives after we transitioned to a company with an audit & supervisory board as listed below. Plans call for these changes to be officially decided at the 84th Regular General Meeting of Shareholders to be held in June 2024 and the meetings of the Board of Directors and the Audit & Supervisory Board, both of which will take place immediately after the General Meeting of Shareholders.
