Notice Concerning Acquisition of CASBEE for Real Estate Certification

Japan Excellent, Inc. (hereinafter "JEI") announces that our two owned properties have acquired CASBEE for Real Estate Certification on March 29, 2024. Details are as follows.

(Reference) Overview of CASBEE for Real Estate Certification

CASBEE (Comprehensive Assessment System for Built Environment Efficiency) is a system for comprehensively assessing and ranking the environmental performance of buildings with regard to aspects such as the enhancement of environmental quality and performance including indoor comfort and consideration for the landscape, in addition to the aspect of environmental consideration such as energy-saving and the use of materials and equipment with a lower environmental burden.

CASBEE for Real Estate Certification is rated on four scales consisting of rank S, rank A, rank B+, and rank B for buildings where one year or more has elapsed since completion.

2. Status of Acquisition of Green Building Certification

As of the date of this release, JEI has acquired Green Building Certification* for 26 properties (90.0% based on leasable area; 76.5% based on number of properties) among 34 owned properties** (excluding one land with leasehold interest).

* Green Building Certification is a general term for DBJ Green Building Certification and CASBEE for Real Estate Certification.

**The residential portion of and the office portion of HAMARIKYU INTERCITY are counted as one property each.
