Notice of acquisition of domestic real estate

Japan Investment Adviser Co., Ltd. (hereinafter referred to as "JIA") acquired the Japanese-style inn "Ryotei Hanzuiryo" (hereinafter referred to as "the Property"), which is located in Unzen City, Nagasaki Prefecture, as our asset on April 1, 2024, as described below. The Property will be the first one for which JIA will cooperate with Onkochishin Inc. (hereinafter referred to as "Onkochishin"), which is a partner for the capital and business alliance.

1. Purpose of Acquisition

JIA considers the development of the real estate business foundation as a priority strategy in the Three-year Business Plan for the period from 2024 to 2026, which was announced in July 2023.

JIA will invest in accommodation facilities around Japan the demand from Japanese and foreign visitors for them is expected to be strong.

For the Property, ownership and operation will be separated, and JIA will engage in the establishment of a financial scheme and the renovation and management of real estate for the Property, while Onkochishin will engage in the operation of the Property.

The synergetic effects through the cooperation of the two companies are expected to improve the added value of the Property from the aspects of facilities and operations, and contribute to regional revitalization and the increase of jobs.
