Since our listing on the Tokyo Stock Exchange in April 2021, the Company has been committed to enhance our corporate value through various initiatives, including expanding our investments in R&D and production facilities in our Semiconductor Business, investing in university-launched start-ups, being selected for the METI Green Innovation Fund, and the acquisition of Raicol Crystals Ltd.. In order to further accelerate the growth of the Company, we believe it is crucial to expedite the commercialization of our current focus areas: power semiconductors, quantum technology, and new business from our frontier technology business division.
